The Green Country Soccer Scholarship Foundation annually awards undergraduate college tuition scholarships to current and former GCSA players. The awards are open to both men and women. The amounts of the awards will be determined by the GCSA Board of Directors based on number of applicants and funds available.

To be considered for an award, the student must meet the following criteria:

- A) The applicant must have participated for a minimum of three (3) years (six seasons) in GCSA recreational or competitive play.
- B) The applicant must have applied for a Federal Pell Grant (submitted a Free Application for Federal Student Aid) and must provide the EFC number contained in the Federal Student Aid Report. Failure to provide this information will result in the applicant being disqualified.
- C) The applicant must submit a certified copy of their high school or current college transcript, which must include BOTH the FALL and SPRING SEMESTER of the preceding academic year. Failure to provide this information will result in the applicant being disqualified.
- D) Incomplete applications will not be considered.
- E) Applicant must enroll in a minimum of 12 hours per semester.
- F) If at any time it is determined that information provided on this application is inaccurate or if there are any changes to the information, the GCSA Scholarship Foundation and/or GCSA Board of Directors reserves the right to reconsider the award.
- G) Notify GCSA immediately if the college you list on the application changes.

### GENERAL INFORMATION:

Evaluation will be made by the GCSA Scholarship Foundation Committee based on GCSA participation, financial need, and academic achievements. The Committee's recommendations will be presented to the GCSA Board of Directors for their approval.

The GCSA Scholarship Foundation scholarship program is consistent with the NCAA Guidelines for NCAA Division I schools. These scholarships must be annual awards (no multi-year awards) and each student must go through the entire selection process each year. This applies to all applicants for GCSA Scholarships.

Every effort will be made to notify the successful applicants by letter of the Committee's decision by July 21<sup>st</sup>, 2011.

All GCSA Scholarship recipients must provide proof of enrollment (each semester) before funds will be disbursed. Proof of enrollment shall consist of a copy of students class schedule (issued by college or university) showing the number of hours enrolled in. All college enrollment verifications are due to the GCSA office before their current college year concludes or their scholarship will not be paid - NO EXCEPTIONS.
